JCCF ANNOUNCES 14TH YEAR OF LILLY ENDOWMENT **COMMUNITY SCHOLARSHIPS**

Lilly Endowment Community Scholarship applications are available November 22nd. Local graduating seniors can pick up applications at the JCCF Office. The applications are also available online on our Website at Jennings Foundation.net.

The scholarship provides four years of undergraduate study on a full time basis at any Indiana public or private university or college. It also provides up to \$800 per year for books and equipment. Twenty nine scholarships have been awarded to Jennings County students since 1998. This year Lilly Endowment has cut the number of scholarships they will be awarding so only one student will be receiving ENDOWMENT this award.
