# Luke Elsner 1st Walk to Remember Raises Nearly \$7000.00





#### The Challenge

The Foundation continues to implement its Gateway 8-08 Initiative with the announcement of a "Funding"

the Future Challenge Match Program. This new challenge match is designed to grow the existing funds in the foundation and seek out new funds. The foundation is challenging donors to increase their existing funds or begin new funds and is providing an incentive for donors to do just that! Using \$30,000 from interest earned in 2007, JCCF is excited to offer this unique "Fund Growing" opportunity to the community to better meet the future needs of the funds. The Foundation will match donations to new or

existing funds until the Match Money in each of the categories is gone.

#### The Program

The "Funding" the Future Challenge is a \$1 for every \$3 donation match for new and existing funds in the Foundation. JCCF has set aside \$30,000 for funding the program distributed as matching money into the following fund

\$9,000—in JCCF Match money for adding to existing Scholarship funds

\$3,000—in JCCF Match money for donors establishing new Scholarship funds.

#### Agency Funds \$6,000 Total

\$4,000—in JCCF Match money for adding to existing funds \$2,000—in JCCF Match money for agencies establishing new funds.

Individual Funds \$12,000 Total

\$9,000—in JCCF Match money for adding to existing funds

\$3,000—in JCCF Match money for donors establishing new Scholarship funds.

Interested donors will need to secure and deposit with the foundation at least \$500 in newly developed funds for existing funds or in newly developed funds for starting a new fund in the foundation. Monies cannot come from any existing foundation source money (grant OR earned interest money) from the foundation but must be new sources of money for the organization or individual fund. *Maximum funds to be accepted as eligible to be matched are \$3,000.* 

#### Eligibility

To be eligible for consideration for the fund matching challenge, interested donors must attend a *mandatory* "Funding" the Future's Announcement and Explanation Meeting to be held at the Jennings County Library on Wednesday October 15, at 7:00 p.m. Participants will be asked to complete and return the *Application & Intent to Participate* in the "Funding" the Future Challenge Match Program.

#### General Disclaimer

As noted, all funds will be matched on a *first-come first-serve basis* until the match money has been depleted. Funds must be a complete match to receive money (at least the minimum of \$500 to be matched). There will be NO PARTIAL matching of funds.

The Community Foundation will be the sole decider of any rulings related to the operation of this *"Funding"* the Future Challenge Match Program.
